I, the undersigned, hereby request that Blue Diamond of Texas ("BDT") enter bids on my behalf in its next live auction on the lot number(s) and up to the maximum bid(s) stated on this form. I understand that absentee bidding is a free service provided by BDT, and that BDT is not responsible for errors or omissions related to my absentee bids. However, in no case shall I be held liable for payment of any amount(s) in excess of that which is stated on this form.

All absentee bidders are also required to complete and submit BDT's Bidder Registration Card. No term or provision of this Absentee Bid Form shall amend or invalidate any term or provision of the Bidder Registration Card.

*Absentee Bid Forms must be submitted no less than 2 hours before the scheduled starting time of the auction. No changes may be made to any Absentee Bid Form later than 2 hours before the scheduled starting time of the auction. **A 10% buyer's premium shall be added to each successful absentee bid.***

In the event of a tie bid, the earliest bid received shall take precedence. All absentee bids shall be executed in conformity with the bidding increments in use during the auction applicable to the lot(s) stated on this form. Winning absentee bids shall be reduced to one bidding increment above the second-highest bid; however, absentee bids of \$25 or less shall not be reduced, and no absentee bid shall be reduced to any amount below \$25.

A valid credit card is required to secure absentee bids. Acceptable credit cards are Visa, MasterCard, and Discovery; BDT does not accept American Express at this time. I certify that I am an authorized user of the credit card listed below, and I understand that my credit card shall be charged immediately after the auction for all my purchases: my signature below authorizes BDT to charge my credit card for the full total amount of my purchase(s) of the lot(s) stated on this form. In the event that BDT's charge to my credit card is declined for any reason, I understand that I am still liable for the total amount of my purchase(s).
